for Trail Bridges.

1. The Mai Municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
2. Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years are eligible for the bidding. New fabricators may also apply in joint venture with an eligible fabricator having the required experience. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the minimum requirements.
3. Bidding documents may be purchased from the Mai Municipality, Office of Municipal Executive, Sitali, Ilam, or [www.bolpatra.gov.np](http://www.bolpatra.gov.np) by eligible Fabricator, on submission of a written application and upon payment of a non-refundable fee of NRS 3000.00 (Three Thousand Only) on **Sanima Bank, Antarik Rajaswa Account (052010040000013)** for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) ( **29<sup>th</sup> April, 2022** ) from the First date of publication of this notice.
5. Bids must be submitted through [www.bolpatra.gov.np](http://www.bolpatra.gov.np), on or before **12:00 noon on 29<sup>th</sup> April, 2022 (2079/01/16)**. Documents received after this deadline shall not be accepted.
6. Bids will be opened in the presence of Fabricator' representatives who choose to attend at Mai Municipality Office on **13:00 on 29<sup>th</sup> April, 2022 (2079/01/16)**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a **minimum of 118000.00( One Lakh Eighteen Thousands Only )**, which shall be **valid for 30 days** beyond the bid validity period.
7. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. **Sanima Bank, Dharauti khata 052010020000008 , Mai Municipality, Ilam.**
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.


