Bid security Amount Should be deposited in **Sanima Bank, Dharauti Account (052010020000008)**. Bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Noon on **2077/08/07**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives (if attended) who choose to attend at **2077/08/07 at 14:00 pm** at the office of **Mai Municipality, Office of Municipal Executive, Sitali, Ilam**. Bids must be valid for a period of **90** days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format amounting to a minimum amount of **Rs.2,15,000.00 (In Words Two Lakh Fifteen Thousand Only)**, which shall be valid for 30 days beyond the validity period of the bid.
4. If the last date of purchasing /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
