

Mai Municipality invites electronic bids from Nepalese eligible bidders for the **Supply, Delivery and Installation of centralized solar street light system in Mai Municipality** under National Competitive Bidding procedures.

- 2) Bidder who chooses to submit their bid electronically may purchase the of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders submitting their bid electronically, should deposit the cost (as specified below) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 3) Pre-bid meeting shall not be held.
- 4) Electronic bids must be submitted to the office *Of Mai Municipality* through PPMO website www.bolpatra.gov.np/egp on or before 12:00 hour on **2077/03/03 (17th, June 2020)** . Bids received after this deadline will be rejected.
- 5) The bids will be opened in the presence of Bidders' representatives who choose to attend on **14:00 Hrs. of 2077/03/03 (17th, June 2020)** at *Mai Municipality, Ilam*. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting Prescribed in the following table which shall be valid for 30 days beyond the validity period of the bid.
- 6) All bids shall be accompanied by a Bid Security for the amount as specified in the table above in local currency. Bidders are required to submit a separate bid security for each contract for which they submit bids. The bid security guarantee shall confirm to the standard format as specified in the





- bid document. The bid security guarantee issued only by the commercial bank approved by Nepal Rastrya Bank shall be accepted by the Employer.
- 7) If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
 - 8) Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
 - 9) The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, the information not provided here will be as per PPA and PPR.
