

Bid security Amount Should be deposited in **Sanima Bank, Dharauti khata 052010020000008** electronic bids must be submitted to through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 2077/01/07. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives (if attended)who choose to attend at 2077/01/07 **at 14:00 pm** at the office of **Mai Municipality, Office of Municipal Executive, Sitali, Ilam**. Bids must be valid for a period of **90** days after bid opening and must be accompanied by a bid security or scanned copy of the bid security
