Bid security Amount Should be deposited in Sanima Bank, Dharauti khata 052010020000008. Electronic bids must be submitted to through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 2077/07/16. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives (if attended) who choose to attend at 2077/07/16 at 15:00 pm at the office of Mai Municipality, Office of Municipal Executive, Sitali, Ilam. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum amount of Rs.75,000.00 (In Words Seventy Thousands Only), which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
